

**OREGON STATE UNIVERSITY ALUMNI ASSOCIATION (OSUAA)**  
**FOOTBALL GIVEAWAY: ALL -STAR TAILGATE EXPERIENCE**

**OFFICIAL RULES**

**1. NO PURCHASE NECESSARY TO ENTER OR WIN.**

2. **HOW TO ENTER:** Beginning on June 1, 2025, at 12:01 AM Pacific Standard Time through July 31, 2025, at 11:59 PM Pacific Standard Time (“**Sweepstakes Period**”), eligible individuals can enter the Oregon State Alumni Association Football Giveaway (“**Sweepstakes**”) by doing one of the following:

(a) OSUAA Membership Purchase: Eligible individuals who purchase an OSUAA membership during the Sweepstakes Period will be automatically entered in the Sweepstakes.

(b) Other Entries: Other eligible individuals may enter the Sweepstakes by entering online at <https://bit.ly/AllStarTailgate25>, by calling 877-678-2837, [or] by emailing [osualum@osualum.com](mailto:osualum@osualum.com) with the subject line, “All-Star Tailgate Sweepstakes” and providing your name, complete address, daytime phone number, and date of birth in the body of the email.

An OSUAA membership purchase or existing OSUAA membership will not increase your chances of winning. Limit one entry per person. Entries become the property of OSUAA and will not be returned. Entries must be received by July 31, 2025, at 11:59 PM PST, when the Sweepstakes ends.

You may not enter more than once by using multiple email addresses, identities, or devices to circumvent the rules. Use of any robotic, automatic, programmed, or similar entry method, or entering more than once, will void all your entries and result in disqualification. OSUAA reserves the right to exclude previous sweepstakes winners from entering this or any future sweepstakes.

3. **ELIGIBILITY:** Open to residents of the 50 United States and D.C., 18 years of age or older as of June 1, 2025, except for employees of the Oregon State University Alumni Association (OSUAA) (“**Sponsor**”), Oregon State University Foundation (OSUF), their respective affiliates, subsidiaries, and agencies (together “**Promotion Parties**”), and members of their immediate family or persons living in the same household. Void where prohibited.

4. **STATEMENT OF ELIGIBILITY.** By entering this Sweepstakes, you represent as follows:

(a) you are not an employee of any Promotion Party or a member of the immediate family or living in the same household as an employee of a Promotion Party.

(b) You have fully complied with these Official Rules, the information you submitted in entering the Promotion is correct, and you have not committed and will not commit any fraud or other deception in entering the Sweepstakes or claiming a prize.

If any of the above representations is false, you agree to return any prize to Sponsor and Sponsor may seek additional remedies.

5. **ODDS OF WINNING:** Odds of winning depend on the number of entries received.

6. **DRAWING AND PRIZE AWARDS:** Sponsor will conduct a random drawing on or about August 5, 2025, to select the winners from among all eligible entries received. Potential winners will be notified by email or phone (at OSUAA's discretion) and must sign and return any required Affidavit of Eligibility and Release within seven (7) days of the date notice is sent or such other date set by Sponsor. A potential winner is not a winner of any prize unless and until eligibility and compliance with these Official Rules have been verified and the potential winner has been notified that verification is complete. Failure to respond within seven (7) days will result in forfeiture of the prize and Sponsor shall have the option to award the prize to an alternate winner. The return of any prize notification or prize as undeliverable may result in disqualification and an alternate winner may be selected. All prizes will be awarded. If a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. If, in Sponsor's opinion, there is such an error, or there is any suspected evidence of tampering with any portion of the Sweepstakes, or if technical difficulties (including viruses and bugs) compromise the integrity of the Sweepstakes, Sponsor reserves the

right, in its sole discretion, to cancel or modify the Sweepstakes in a manner deemed appropriate by the Sponsor. In the event of termination, winners will be selected from among all eligible entries received as of date of termination. In the event a dispute arises as to the identity of a potentially winning entrant, entries will be declared made by the name on the online entry form.

8. PRIZES: A total of four (4) winners will be randomly selected from all eligible entries. Each winner will receive one tailgate parking and game ticket package for one Oregon State University regular season home football game at Reser Stadium (660 SW 26th St, Corvallis, OR 97331) (the “All-Star Tailgate Experience”), which includes the following:

- (a) One (1) parking space of Sponsor’s choice at Reser Stadium, beginning [three (3)] hours prior to the scheduled home game start time on game day;
- (b) Two (2) club-level game tickets;
- (c) One (1) meal per ticket holder [buffet meal in VIP area at CH2M HILL Alumni Center, value \$25 per meal], not including alcohol; and
- (d) Access to the VIP area at CH2M HILL Alumni Center beginning [three (3) hours] prior to the scheduled home game start time on game day.

ARV: \$220 per prize. The prize consists of only those items specifically listed above. Travel not included. Sponsor reserves the right to determine which regular-season home game each winner may attend. Regular season home game times and dates are subject to change and Sponsor reserves the right to notify each winner of game-specific All-Star Tailgate Experience information up to twenty-four (24) hours prior to the scheduled home game start time. Game-specific information comprises the elements of the All-Star Tailgate Experience listed in Sections 8(a)-8(d), above. No substitution or transfer of prize is permitted by the winner.

Limit one prize per person. Sponsor reserves the right to substitute a prize of equal or greater value in the event the offered prize is unavailable. Prizes are not redeemable for cash, exchangeable or transferrable.
